

2018 Oilers MBNA Rewards Trip to Toronto Contest Rules

1. **CONTEST PERIOD:** The "Oilers® MBNA® Rewards Trip to Toronto" Contest ("**Contest**") begins at 7:00 a.m. Mountain Time ("**MT**") on June 15, 2018 and ends at 9:59:59 p.m. MT on July 13, 2018 (the "**Contest Period**"). The sponsors of this Contest are The Toronto-Dominion Bank operating a division as MBNA®, Oilers Entertainment Group Canada Corp (OEGCC) ("**MBNA**" or "**Sponsor**").
2. **ELIGIBILITY:** The Contest is only open to Edmonton Oilers MBNA Rewards Mastercard credit card primary cardholders who are legal residents of Northern Alberta (defined as locations in Alberta north of and including the City of Red Deer, Alberta) and are 18 years of age or older at the time of entry. Employees, agents and representatives of the Sponsor, Mastercard International Incorporated, each of their respective subsidiaries and affiliates and each of their respective advertising and promotion agencies or their subsidiaries and affiliates and Ryan Strome (collectively, the "**Contest Parties**"), are not eligible to win, nor is any person with whom any such employee, agent or representative is domiciled.
3. **HOW TO PARTICIPATE:**
"**Entrant**" means (i) in respect of the method of entries described in this Paragraph 3, the Primary Cardholder of the Edmonton Oilers MBNA Rewards Mastercard credit card Account (the "**Account**") associated with the approved application (defined below) and (ii) in respect of the Alternate Means of Contest Entry described in Paragraph 4 below, the person whose name is printed on the entry.

To enter, Entrants must apply for the Edmonton Oilers MBNA Rewards Mastercard credit card during the Contest Period, and if approved, will receive one (1) entry into the Contest.

4. **ALTERNATE MEANS OF CONTEST ENTRY:**

NO PURCHASE NECESSARY. To enter the Contest without making a purchase, legibly hand-print your name (as it appears on your Edmonton Oilers MBNA Rewards credit card), complete mailing address (including postal code), telephone number and age, on a plain piece of paper and mail it in a sealed postage pre-paid envelope to:

Each mail-in entry request will result in one (1) Contest entry. Entries by this method of entry are unlimited during the duration of the Contest. Each entry must be mailed in a separate envelope with sufficient postage and postmarked during the Contest Period, and must be received on or prior to July 13, 2018. MBNA will not be responsible for late, lost, invalid, illegible, delayed incomplete, stolen, misdirected, or postage due to entries. By using this Alternate Means of Contest Entry, you are providing your permission for the Sponsor to enter you in the Contest and to communicate with you via telephone, in writing or by email.

All entries become the property of the Sponsor and will not be acknowledged or returned. Entrants may not enter by both methods of entry and attempts to do so will render all entries void.

No photocopied, computer-generated facsimiles, mechanically reproduced, or mass entries permitted. Incomplete entries are ineligible.

The decisions of the Sponsor with respect to all aspects of this Contest are final and binding on all entrants without right of appeal, including, without limitation, any decisions regarding the eligibility/disqualification of entries and/or entrants.

By entering this Contest, you consent to the collection, use and sharing of information about you by MBNA for the purpose of administering this Contest in accordance with the MBNA Privacy Code at www.mbna.ca/privacy. MBNA may share your information with third parties that assist us with administering the Contest.

All entries are subject to verification. The Sponsor reserves the right, in its sole discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor) to participate in this Contest. Failure to provide such proof in a timely manner may result in disqualification. The sole determinant of the time for the purposes of a valid entry in this Contest will be the Sponsor's official clock.

5. **PRIZES:** There is one (1) Prize (the "Prize") available to be won, consisting of a trip for two (2) people to attend an event in Toronto, Ontario with Ryan Strome on Saturday, August 25, 2018. Trip includes roundtrip economy airfare for the Prize winner and one (1) guest from Edmonton to Toronto; two (2) night(s) of standard double-occupancy hotel accommodation; choice of one of the following events: (i) play golf with Ryan Strome, (ii) attend a cooking class with Ryan Strome, (iii) go on a walking tour of Toronto with Ryan Strome, or (iv) an activity mutually agreed upon by all parties. The approximate retail value of the Prize is \$10,000 CDN. Prize winner will not be entitled to any difference between the retail value and actual cost of the trip.
