

Edmonton Oilers® MBNA Rewards Mastercard® Ticket Contest Rules

1. **CONTEST PERIOD:** The Edmonton Oilers MBNA Rewards Mastercard Ticket Contest ("**Contest**") begins at 9:00 a.m. Eastern Time ("**ET**") on October 29, 2018 and ends at 11:59:59 p.m. ET on November 26, 2018 (the "**Contest Period**"). The sponsor of this Contest is The Toronto-Dominion Bank operating a division as MBNA® ("**MBNA**" or "**Sponsor**").
2. **ELIGIBILITY:** The Contest is only open to Edmonton Oilers MBNA Rewards Mastercard primary cardholders who are legal residents of Alberta living within a 50 mile (80 km) radius of the municipal limits of the City of Edmonton and are 18 years of age or older at the time of entry. Employees, agents and representatives of the Sponsor, Mastercard International Incorporated, Oilers Entertainment Group Canada Corp., each of their respective subsidiaries and affiliates and each of their respective advertising and promotion agencies or their subsidiaries and affiliates (collectively, the "**Contest Parties**"), are not eligible to win, nor is any person with whom any such employee, agent or representative is domiciled.
3. **HOW TO PARTICIPATE:**
"**Entrant**" means (i) in respect of the method of entries described in this Paragraph 3, the Primary Cardholder of the Oilers MBNA Rewards Mastercard Credit Card Account (the "**Account**"); and (ii) in respect of the Alternate Means of Contest Entry described in Paragraph 4 below, the person whose name is printed on the entry.

The Entrant will receive one (1) entry into the contest after applying for an Edmonton Oilers MBNA Rewards Mastercard® Credit Card account between **October 29, 2018 and November 26, 2018** and being approved.

The winning Accounts must be in good standing and not otherwise have privileges suspended at the time of entry, winners selection and/or awarding of the prizes. Only an Account that is in good standing (at time of entry, winners selection and awarding of the prizes) and issued to an identifiable end user are eligible.

4. **ALTERNATE MEANS OF CONTEST ENTRY:**

NO PURCHASE NECESSARY. To enter the Contest without making a purchase, legibly hand-print your name (as it appears on your Oilers MBNA Rewards credit card), complete mailing address (including postal code), telephone number and age, on a plain piece of paper and mail it in a sealed postage pre-paid envelope to:

Each mail-in entry request will result in one (1) Contest entry. Entries by this method of entry are unlimited during the duration of the Contest. Each entry must be mailed in a separate envelope with sufficient postage and postmarked during the Contest Period, and must be received on or prior to

November 26, 2019. MBNA will not be responsible for late, lost, invalid, illegible, delayed incomplete, stolen, misdirected, or postage due to entries. By using this Alternate Means of Contest Entry, you are providing your permission for the Sponsor to enter you in the Contest and to communicate with you via telephone, in writing or by email.

All entries become the property of the Sponsor and will not be acknowledged or returned. Entrants may not enter by both methods of entry and attempts to do so will render all entries void.

No photocopied, computer-generated facsimiles, mechanically reproduced, or mass entries permitted. Incomplete entries are ineligible.

The decisions of the Sponsor with respect to all aspects of this Contest are final and binding on all entrants without right of appeal, including, without limitation, any decisions regarding the eligibility/disqualification of entries and/or entrants.

By entering this Contest, you consent to the collection, use and sharing of information about you by MBNA for the purpose of administering this Contest in accordance with the MBNA Privacy Code at www.mbna.ca/privacy. MBNA may share your information with third parties that assist us with administering the Contest.

All entries are subject to verification. The Sponsor reserves the right, in its sole discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor) to participate in this Contest. Failure to provide such proof in a timely manner may result in disqualification. The sole determinant of the time for the purposes of a valid entry in this Contest will be the Sponsor's official clock.

5. **PRIZES:** There are one hundred (100) prize packages available to be won, consisting of two admission tickets to an Edmonton Oilers game ("Game") in Edmonton, Alberta in the month of January 2019 (the "Prize") as determined by the sponsor. The approximate retail value of the Prize is \$180 CDN.

Without limiting the generality of the foregoing, the following general conditions apply to the Prize: All Prize details, including seat locations and game date will be determined at the sole discretion of the Sponsor. Actual value of the Prize may vary. No additional compensation or substitution will be awarded for the difference in the stated approximate retail value and the actual value of the Prize.

The Game date and time may be subject to change. The terms and conditions of the tickets awarded as a Prize will govern in the event the Game is not played due to weather conditions, an act of God, an act of terrorism, civil disturbance, or any other reason. The Sponsor will not be responsible for the acts of God, acts of terrorism, civil disturbances, work stoppage, or any other natural disaster outside their control that may cause the cancellation or postponement of the Game. Game tickets awarded as part of any Prize may not be resold or offered for resale. Any such resale may result in disqualification and prize forfeiture, and may invalidate the license granted by the game ticket(s).

All incidental costs and expenses associated with the Prize that are not specifically referred to in these Contest Rules, including (without limitation) transportation to and from the Games, food, beverages, concessions are not included and are the sole responsibility of the selected Entrant. 7. **PRIZE AWARDING:** If you are a selected Entrant in the Draw, you will be provided specific instructions on what you are required to do in order to claim your Prize. **The Prize must be accepted as awarded and no substitution, transfer, conversion or assignment of Prize will be allowed, unless at the discretion of the Sponsor which may substitute a Prize of equal or greater value.
